Aurum PropTech continues growth momentum

Revenue from operations during this quarter 3Q FY23 was ₹385.6 million, 512% of the revenue of 3Q FY22

CONSOLIDATED RESULTS AT A GLANCE (3Q FY23 COMPARED WITH 2Q FY23)

- Revenue from operations for the quarter was ₹385.6 million, as compared to ₹ 283.0 million in 2Q FY23, up 36.3%
- Total income for the quarter was ₹ 411.5 million as compared to ₹ 308.4 million in 2Q FY23, up 33.5%
- EBITDA for the quarter was ₹ 19.5 million as compared to ₹ (34.2) million in 2Q FY23, improved by ₹ 53.9 million

CONSOLIDATED RESULTS AT A GLANCE (3Q FY23 COMPARED WITH 3Q FY22)

- Revenue from operations for 3Q FY23 was ₹ 385.6 million, as compared to ₹ 75.3 in 3Q FY22 up 406.7%
- Total income for 3Q FY23 was ₹411.5 million as compared to ₹87.4 in 3Q FY22 up 370.8%
- EBITDA for 3Q FY23 was ₹ 19.5 million as compared to ₹ (26.0) million in 3Q FY22, improved by ₹ 45.5 million

Commenting on the results, Ashish Deora, Founder and CEO, Aurum Ventures said

"The revenue this quarter saw an exponential growth of \mathbb{R} 385.6 million which is 5x of our 3Q revenue last year. We are on track to achieve our targeted revenue by 4Q FY23. Our revenue growth momentum shows the execution discipline of our strategy and validates the growth of the PropTech sector as a whole. We continue to sharpen our focus on delivering technology, capital and services for real estate consumers and developers.
